Terms and Conditions

- A 50% deposit is required to secure all reservations.
- Final payment is due upon arrival. If payment is not received in full upon arrival (1) the deposit and all payments shall be forfeited and (2) the reservation shall be revoked and become null in void. Failure to meet payment obligations will result in the full and complete balance becoming due immediately with finance changes accruing as applicable.
- If Vessel fails to pay any amount within three (3) days after notice has been given from Chelsea Piers Marina that the same is due, the delinquent amount shall bear interest from the date initially due at a rate equal to lesser of one and half percent (1.5%) per month or maximum permitted by law. In the event that Vessel fails to pay any amount due hereunder, Vessel agrees to pay Chelsea Piers Marina all costs associated with the collection of such amounts, including, with limitations, actual attorney's fees, cost, and expenses.
- The dockage day starts at 1:00pm. Checkout time is 11:00am the following day. Any vessel occupying a slip after 11:00am will be charged dockage for that night. Late departures can be arranged upon request with the Marina Manager.
- Catamarans are 1.5x prevailing rate and trimarans are 2x rate

Cancellation Policy

- Reservations cancelled:
- 60 days or more prior to arrival shall receive a refund, less 5% of initial deposit.
  - 59 to 14 days prior to arrival shall receive 75% refund of initial deposit
  - 13 to 8 days prior to arrival shall receive 50% refund of initial deposit
  - 7 days of arrival will receive no refund.
- Notice of early departure must be given 7 days prior to amended departure or full dockage fees will apply.
